## MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COOPERATION

S.K.C.G. AUTONOMOUS COLLEGE PARALAKHEMUNDI, GAJAPATI

S.K.C.G. Autonomous College and the Lokabhasha Prachara Samitih (Regd. No.1289/82, 1983-84) have agreed for signing an MoU for facilitating to develop of cooperation and exchange in the areas of Mutual Academic Interest. It is desirable to enhance research and educational processes at both the Colleges/institutes and to strengthen mutual understanding between their respective staff, scholars and students. The Lokabhasha Prachara Samitih, represented by the National President and S.K.C.G. Autonomous College, represented by the Principal, hereby agree on academic and educational cooperation and have set forth the following Articles of Mutual Agreement.

#### Article 1

MoU will be carried out within the frame work of the respective laws and regulations of the College as set by DHE, Govt. of Odisha and the organization Lokabhasha Prachara Samith and is not intended to create any legally binding rights or obligations.

#### Article 2

This Memorandum of Understanding (henceforth "MoU") intends to set out the general principles of mutual cooperation in the field of spreading and promotion of the **SKILL BASED SANSKRIT EDUCATION**, according to which the sides may jointly identify areas of academic interest and carry out cooperative activities on the areas of mutual interest and carry out cooperative activities on the basis of reciprocity and mutual benefit.

#### Article 3

Both institutes agree on, but is not limited to, the following based on their academic and educational needs:

- 1. Exchange of scholars and staff.
- 2. Exchange of academic information and materials.
- 3. Joint research activities and publications.
- 4. Organisation and participation in conferences and academic meetings such as courses, seminars, workshop, symposia or lectures.
- 5. The effort towards the promotion of Sanskrit language and skill based Sanskrit teaching jointly.
- 6. Other academic exchanges that both organizations agree to.
- 7. Department of Sanskrit, S.K.C.G. Autonomous College and The Lokabhasha Prachara Samitih will execute the operations.

#### **Article 4**

The implementation of each exchange programme or joint project based on this agreement shall be negotiated on a case-by-case basis and agreed upon in writing by both organizations. Any such exchange programme or collaborative project entered into, as outlined above, will form an appendix to this basic agreement.

#### Article 5

The exchange programmes and/or projects, as mentioned in Article 4, are not intended to be legally binding documents. They are meant to describe the nature and suggest the guidelines of the programme or project. Nothing, therefore, shall diminish the complete autonomy of either institutes/college, nor will any constraint be imposed by either upon the other carrying out the agreement.

#### Article 6

The sides will consult together upon the request of either side regarding any matter relating to the term so this MoU and will endeavour jointly in a spirit of cooperation and mutual trust to relative any difficulties or difficulties or misunderstandings which may arise.
